Who was born the (blank) day of (blank) A.D. 1838 in (blank) County of (blank) State of (blank).

He first entered the service the 11th day of August 1862 as a private in compy H. Cap't Rhodes 45th Reg't Ohio Vol. Inf. going into camp at Camp Chase near Columbus, Ohio and was mustered out of the service the 12th day of June 1865 at Camp Harker, Tenn. by reason of close of the war. Com'd Lafferty was through the brunt of the service and saw much hardship incident to a soldiers life in active duty in an enemys country.

His regiment at times was mounted, and then hot pursuit after Gen. John Morgan in his raid through Indiana and Ohio in July 1863 was one of the pleasant trips in a soldiers experience.

He was in the Atlanta Campaign and with Sherman in his march to the sea. Comrade Lafferty died the 12th day of May 1892 at his home in Mutual, Champaign County, O.

He was a merchant in the Village and was a useful citizen in the long time the Village Postmaster, was of a frail constitution, never seemingly rugged and suffered a long seige of sickness and was buried in the little cemetry. Just west of the village with the honors of the Post, surviving comrades strewing the grave with the emblems of Love, Purity, & Victory.

Who was born the (blank) day of (blank) A.D. 1829 in Coshocton County of Coshocton State of Ohio.

He was a merchant previously to his entry into the service, the 13th day of July, 1862 and was appointed to a sergeancy in Compy E, 79 Ill. Reg't Vol. Inf. He was mustered out of the service the 24th day of Oct. 1865 by reason of Genl order No. 77 from the war department.

He was not generally known outside the G.A.R. circles on acc't of his retiring disposition, he lived in Urbana but few years moving into property on South Main St. below Broad St.

He died the 9th day of Jany 1890 and his remains were sent to Terre Haute Ind. for interment via the PanHandle R.R.Co. W.A. Brand Post G.A.R. telegraphed the G.A.R. at Terre Haute to receive the remains and give them an honored burial as prescribed by the order if so desired by the friends of the comrade at that place.

Comrade Chas. Laupper

Who was born the 2nd day of September A.D. 1838 in Newark County of (blank) State of New Jersey and first entered the United States service from the Ohio States Guars the 2nd day of May, 1864 as a private in compy A Capt Weaver 134 Regt Ohio Vol. Inf. going into camp at Camp Chase near Columbus, Ohio. Was promoted to 4th corporal and was mustered out as such the 31st day of Aug. 1864 at Camp Chase by reason of expiration (100days).

The only engagement in which he participated was the skirmish at Port Walthall on the 17th day of June, 1864. When the advanced picket lines of the Union Forces: had been driven in from their new position.

Was not sick in hospital, or even taken prisoner.

His [mess]. In the service consisted of the following comrades J.K. Cheetham, Peter Murphy, Chas. [Hies], Tobias Taylor.

In the trenches, about Petersburgh, Va. was interesting, and important times to him, with the booming of cannon and the crack of the musket ringing in his ears at all times almost.

Comrade B.F. Leonard

Who was born the 28th day of Sept. A.D., 1828 in (blank) County of (blank) State of New York.

He first entered the service the 12th day of August 1862 as a private soldier on Compy G. 72 Reg't Ills. Vol.Inf. The regiment was termed the Board of Trade Reg't of Chicago as it was raised principally in Chicago.

He promoted to a sergeancy and after to Orderly Serg't of his compy. Was dischaged from the service in 1863 by reason of Wounds rec'd in the assault on Vicksburg, Miss by being shot through the thighs while charging the enemys works on the 22nd day of May, '63. After recovering from wounds he was not able for action duty in the Reg't and and was mustered out of the service the 30th day of July 1863 by reason of Surgeons Certificate of Disability.

We all remember Com'd Leonard as a patriotic citizen and a devoted Grand Army man and after his coming among us Foreman and Mechanical Superintendent of the United States Rolling Stock Compy works here; the interest and enthusiasm he created whenever he could relate his army experience; being a fluent talker he enlisted the sympathy of his hearers at all times on the subject of the war. His voice [purse] was ever ready to respond to the necessities of the hour. He removed from us going to Anniston Ala. Yet he retained his membership W.A. Brand Post until his death the 24 day of July 1889. His remains were brought north and entered in the beautiful Oak Dale Cemetery at Urbana, O, bereaved wife and child. The surviving comrades contributed the emblems of Love, Purity and Victory and strewed them over the remains as the last sad rite due all deceased comrades.

Who was born the 1st day of Febrary A.D., 1841 in, Near Lancaster. County of Lancaster, State of Pennsylvania.

He first entered the service the 27th day of Sept. 1862 from Lancaster, Pa. And was assigned to Comp'y C, Cap't Herr, 17th Pa Vol. Cav. And being a sadler by trade was promoted Sadler of the Reg't the 8th day of October, 1862 was detailed afterward as orderely to General Sykes, commanding 2nd Div. 5th Army Corps. Promoted to a sargency the 1st day of Sept., 1864; and was mustered out of the service the 16th day of June 1865 by reason of close of the war and order from the War Deptmt. He never enlisted but the one time the war closing shortly before the expiration of his first term of enlistment. The first engagement in which he participated was the skirmish at Occoguan Creek, Va. Dec. 19 & 20, 1862; followed by participation in engagements at Wolf Run [Shoals], Va. Dec 25 to 26; skirmish at Nebasco Creek, Va Dec. 27; Engagement at point near Occoguan, Va. Dec. 28, Chancellonsville Campaign, Apr. 27 to May 6, 1863; Battle of Chancellonsville, May 1 to 4; Battle of Brandy Station June 9. Gettysburgh Campaign June 9 to July 31. Skirmish near Aldir, June 17 to 23rd. Running fight to Upperville and skirmish at Middleburg June 21. Battle of Gettysburgh, Pa July 1 to 3. Battle of Boonsboro, July 6 & 7.

Was at the general "RoundUp" of Gen. R.E. Lee at Appomattaox, C.H. April 8 to 9, 1865.

Comrade Lewis was never sick, and confined in the hospital. Was never taken as prisoner of war. Was with his regiment from start to finish and what glory there is, in a soldier having done his duty well and faithfully, should certainly rest upon his brow. To be present at Appomattox after a cha of almost 4 years, when the Magnamimous Grant detailed the liberal terms to General R.E. Lee for his surrender, was enough for the time to compensate for the many hardships endured in the various lines of duty as a soldier. He names as some of his intimate associates in the service Comnrades Capt B.M. Herr, Barton Reams and Saml Lewis.

Comrade Armitger B. Lilly

Who was born on the 5th day of September A.D., 1841 in (blank) County of Franklin, State of Ohio.

He first entered the service at the Village of Middletown Wayne Twp. Champaign County State of Ohio the 18th day of October 1861, as a private soldier in Compy H, Capt Wm McAdams 66th Reg't Vol. Inf. Going into camp at Camp McArthur near Urbana, Ohio and was mustered out of the service the 30th day of Jany 1863, at Baltimore Md. By reason of surgeons certificate of disability for military service. The first engagement in which he participated was the battle of

Port Republic, Va. June 9th, 1862; followed by participation in the battles of Cedar Mtn., Va. Aug. 9, 1863; Antietam Md. Sept. 17, 1862.

He was never wounded but was confined in hospital at Baltimore and Harpers Ferry, Va. was never taken prisoner. He names as comrades with whom he was intimately associated in the service, Robt Simpson, and Orville Stokes, and most important event in his military career as being at the battle of Port Republic, Va.
